



## ACTIVITY OF NON - FINANCIAL ENTERPRISES<sup>1</sup> FOR 2012 (PRELIMINARY DATA)

#### 1. Overview

According to preliminary data at the National Statistical Institute 312 458 non-financial enterprises have submitted their annual reports for 2012 and have made 121 923 million Levs of production value, have generated 35 536 million Levs of value have added at factor cost and have employed 1 878 935 persons.




Figure 1. Structure of enterprises by economic sectors and years

Figure 2. Structure of production value by economic sectors and years




Figure 3. Structure of value added at factor cost by economic sectors and years









Figure 4. Structure of persons employed by economic sectors and years



## 2. Industry

According to preliminary data 32 749 industrial enterprises have submitted annual reports on their activities in 2012, which were 10.5% of the total number of reported non-financial enterprises at the NSI.

In 2012 the production value of industrial enterprises at current prices exceeded 63 127 million Levs, or 51.8% of total value of non-financial enterprises. Compared to 2011, there was a change in the structure by sectors - the share of sector 'Electricity, gas, steam and air conditioning supply' increased by 1.3 percentage points, reaching 15.3% of industrial production at the expense of reduced share of sector 'Manufacturing'.





Figure 6. Structure of production value in the industrial enterprises by years

By preliminary data in 2012 the value added at factor cost in the Industry was 14 382 million Levs at current prices, which formed 40.5% of total value of non-financial enterprises. Compared to 2011 the changes in the structure by activities were negligible – less than 1 percentage point.






Figure 7. Structure of value added at factor cost in the industrial enterprises by years



In 2012 the number of persons employed in the industrial enterprises was 617 419 persons which formed 32.9% of total employment in non-financial enterprises.

#### 3. Construction

Annual reports on their activities in 2012 at the NSI were submitted by 19 042 construction enterprises, or 6.1% of the total number of non-financial enterprises.

According to preliminary data in 2012 the production value in construction sector was 12 705 million Levs at current prices which formed 10.4% of total value of non-financial enterprises.




Figure 10. Structure of production value in the construction enterprises by years

■Specialised construction activities





In 2012 the construction enterprises realised the value added at factor cost for 2 405 million Levs at current prices, or 6.8% of total value of non-financial enterprises. In comparison with the previous year a change of the structure of the main construction activities was observed. The share of 'Specialised construction activities' increased by 5.1 percentage points and reached to 30.3%, and the shares of 'Construction of buildings' and 'Civil engineering' fell by 4.5 percentage points and 0.6 percentage points respectively.

The number of persons employed in the construction sector in 2012 was 151 277 and formed 8.1% of total employment in non-financial enterprises.




Figure 12. Structure of persons employed in the construction enterprises by years





## 4. Wholesale and retail trade; repair of motor vehicles and motorcycles

According to preliminary data the annual reports on their activities in 2012 at the NSI were submitted by 138 541 trade enterprises, or 44.3% of the total number of reported non-financial enterprises.

In trade sector the production value in 2012 was 16 047 million Levs at current prices, which formed 13.2% of total value of non-financial enterprises.




Figure 14. Structure of production value in the trade sector by years

In 2012, the value added at factor cost in trade sector reached 7 246 million Levs at current prices, or 20.3% of total value of non-financial enterprises. Compared to 2011 the structure of value added changed by activities, as the share of 'Retail trade, except of motor vehicles and motorcycles' rose by 1.4 percentage points and reached 29.9%, while the share of 'Wholesale and retail trade and repair of motor vehicles and motorcycles' fell by 0.2 percentage points to 8.7%, and the share of 'Wholesale trade, except of motor vehicles and motorcycles' fell by 1.2 percentage points.

According to preliminary data the number of persons employed in trade sector in 2012 was 508 022 and formed 27.0% of total employment in non-financial enterprises.




Figure 16. Structure of persons employed in the trade sector by years





## 5. Services

By preliminary data the annual reports on their activities in 2012 at the NSI have submitted 122 126 enterprises in the service sector, or 39.1% of the total number, as their share increased by 0.4 percentage points compared to the previous year.






Figure 17. Structure of enterprises in the service activities by years

In 2012, the production value in service sector was 30 044 million Levs at current prices which formed 24.6% of total value of non-financial enterprises. In the structure by activities, compared to 2011, only the share of 'Information and communication' decreased by 1.5 percentage points, while all other activities increased slightly or remained the level from the previous year.










According to preliminary data, in 2012 the service sector generated value added at factor cost for 11 503 million Levs at current prices, or 32.4% of total value of non-financial enterprises.

Figure 19. Structure of value added at factor cost in the service activities by years








The number of persons employed in the service sector in 2012 was 602 217, or 32.0% of total employment in the non-financial enterprises, and their share increased by 0.7 percentage points compared to 2011.

### Methodological notes

**Coverage** - the non-financial enterprises on Structural Business Statistics include all sections by NACE Rev. 2, with the exception of 'Agriculture, forestry and fishing', 'Financial and insurance activities', 'Public administration, education, human health and social work activities', 'Activities of membership organisations' and 'Activities of households', in compliance with the Regulation (EC) 295/2008 on SBS.

**Number of enterprises** – includes all non-financial enterprises, which were active during whole or part of the reference year (have realised revenue from sales or have had at least one person employed) and have submitted their annual reports in the National statistical Institute or National Revenue Agency.

**Turnover** includes the value of all revenue from sales of own products, goods bought and sold in the same condition, services provided and row materials sold, including accrued excise duties, which are invoiced during the reference period. It does not include the revenue from sales of fixed assets, the income from financing, the financial and the extraordinary revenue. The value of turnover does not include accrued taxes on the type of value added tax (VAT) which are charged to the end user.

The production value includes the value of turnover, reduced by the balance sheet of assets sold without own fixed assets. The changes in stocks of products and work in progress, as well as the costs incurred to acquire the assets by economic means are also included.

Value added at factor cost includes the production value, reduced by the amount of the excise duties and operating expenses, excluding those for the personnel and for depreciation, and increased by the income from financing.

**Number of persons employed** includes all persons employed working in a given enterprise on full or part-time, including seasonal workers, home workers, working owners, employees under contract for management and control, employees in civil contracts that do not work with another employer and unpaid family workers. It does not include those absent for an unlimited time, as well as those provided under contract by other companies.
