



# PRODUCTION AND DELIVERIES OF ENERGY PRODUCTS, FEBRUARY $2016^{1,2}$

## **Production of energy products**

In February 2016 compared to January 2016 a decrease is reported for the production of:

- solid fuels by 20.5% to 2 843 thousand tonnes;
- unleaded motor gasoline by 12.1% to 153 thousand tonnes;
- transport diesel by 8.0% to 207 thousand tonnes;
- natural gas by 25.0% to 6 million m<sup>3</sup>;
- electricity by 21.1% to 3 706 GWh.

No change for the production of liquefied petroleum gases (Annex, Table 1).

In February 2016 compared to February 2015 an increase is reported for the production of:

- liquefied petroleum gases by 28.6%;
- unleaded motor gasoline by 109.6%;
- transport diesel by 113.4%.

Production of oil products compared to February 2015, when a planned repair of production capacities was done, was restored to its normal levels.

A decrease is reported for the production of:

- solid fuels by 9.6%;
- natural gas by 25.0%;
- electricity by 13.2%.

## **Deliveries of energy products**

In February 2016 compared to January 2016 a decrease is reported for the deliveries of:

- solid fuels by 20.7% to 2 918 thousand tonnes;
- liquefied petroleum gases by 13.2% to 33 thousand tonnes;
- transport diesel by 2.7% to 107 thousand tonnes;
- natural gas by 25.5% to 304 million m<sup>3</sup>;
- electricity by 20.3% to 2 974 GWh.

No change for the deliveries of unleaded motor gasoline (Annex, Table 2).

<sup>&</sup>lt;sup>1</sup> The survey on energy products is conducted every month in accordance with the Regulation (EO) № 1099/2008 of the European Parliament and of the Council of 22 November 2008 on energy statistics, amended by the Commission Regulation (EU) No 147/2013 of 13 February 2013 of the European Parliament and of the Council as regards the implementation of updates for the monthly and annual energy statistics. The survey aims to submit information on the production and inland deliveries of the main energy products - electricity, solid fuels, natural gas and petroleum products. The reporting units are producers, importers and exporters of energy products. Production and deliveries of the energy products are the main observed indicators.

In February 2016 compared to February 2015 an increase is reported for the deliveries of:

• liquefied petroleum gases - by 6.5%.

A decrease is reported for the deliveries of:

- solid fuels by 12.2%;
- unleaded motor gasoline by 26.8%;
- transport diesel by 29.1%;
- natural gas by 4.4%;
- electricity by 4.5%.





### Methodological notes

#### **Solid fuels**

*Production* - includes Hard coal, Lignite and Solid fuels from coal. Producers report quantities calculated after any operation for removal of inert matter.

*Deliveries* - quantities delivered to the internal market. They are equal to the total of the deliveries to the different types of consumers: producers' own use, main activity power stations, coking plants and patent fuel plants, industry, iron and steel industry and others.

#### **Petroleum products**

Production - includes production of finished products at a refinery or blending plant.

*Deliveries* - wholesale deliveries to the domestic market of finished petroleum products from producers, importers/exporters.

Deliveries of petroleum products are defined as: primary product receipts + gross refinery output + recycled products - refinery fuel + imports - exports - international marine bunkers + interproduct transfers - products transferred - stock changes.

#### Natural gas

*Production* - includes all dry marketable production within national boundaries, including offshore production. Production is measured after purification and extraction of NGLs and sulphur. Excludes extraction losses and quantities reinjected, vented or flared. Includes quantities used within the natural gas industry; in gas extraction, pipeline systems and processing plants.

*Deliveries* - total natural gas, distributed for the internal market, including own use and losses. This is defined as: *Indigenous production* + *Imports* - *Exports* - *Stock change*.

Data are presented in million cubic metres assuming reference gas conditions 15°C and 101.325 kPa.

## **Electricity**

*Production* - includes produced electricity from Thermal power plants, Nuclear power plant, Hydro power plants, Pumped storage plant and electricity, obtained from wind generators and solar panels. *Deliveries* - sum of net produced electricity and net import.

Figure 1. Production and deliveries of solid fuels




Figure 2. Production and deliveries of liquefied petroleum gases






Figure 3. Production and deliveries of unleaded motor gasoline




Figure 4. Production and deliveries of transport diesel






Figure 5. Production and deliveries of natural gas




Figure 6. Production and deliveries of electricity
