





BULGARIA AND EU: GROSS DOMESTIC PRODUCT, SECOND QUARTER OF 2018 (PRELIMINARY ESTIMATES)

Gross Domestic Product (GDP) in the second quarter of 2018 increased by 0.4% in the EU-28 compared to the previous quarter by seasonally adjusted data. For the same period, GDP in Bulgaria increased by 0.8% (Table 1 of the Annex).

Compared to the previous quarter, in the second quarter of 2018, Malta recorded the highest economic growth - 1.9%, Estonia and Romania - 1.4% each, Slovakia and Croatia - 1.1% each.



Compared to the same quarter of the previous year, seasonally adjusted data showed an increase in GDP in the EU-28 by 2.1% and in Bulgaria by 3.4%.

In the second quarter of 2018, compared to the same quarter of the previous year, the highest economic growth was observed in Malta - 5.7%, Poland - 5.0%, Hungary - 4.6%, Latvia - 4.4%, Slovenia - 4.3%.
