



ACTIVITY OF FINANCIAL ENTERPRISES AND ASSOCIATIONS AND FOUNDATIONS IN 2018 (PRELIMINARY DATA)

1. Insurance companies

For 2018 a total of 52 licensed insurance companies have submitted their annual reports at the National Statistical Institute, with balance value of assets as of 31.12.2018 for 6 198 million BGN and realised turnover¹ for 2 672 million BGN.




Figure 1. Balance value of assets and turnover of insurance companies by years

In 2018 the insurance companies have reported a positive financial result of their activity for 90 million BGN. In the life insurance sector profit of 29 million BGN is realised while in nonlife insurance sector the profit reached 61 million BGN.




Figure 2. Financial result of insurers by years

2. Pension Companies and Pension Funds

Total of 9 pension companies have been active in 2018, with balance value of assets as of 31.12.2018 for 421 million BGN.

The operating income of pension companies for 2018 is 184 million BGN and the realised profit amounted to 59 million BGN.

For the reference 2018 28 licensed pension funds have submitted annual reports for their activity at the NSI, of which 18 are compulsory (9 universal and 9 professional funds), and 10 are voluntary. The balance value of their assets as of 31.12.2018 is 13 463 million BGN and the investments reached 12 192 million BGN.




Figure 3. Structure of investments of pension funds by kind and years

The total number of insured persons in pension funds as of 31.12.2018 is 4 669 768 and the gross receipts from contributions reached 1 541 million BGN.



3. Special Investment Purpose Companies

For the reference 2018 at the NSI were submitted 257 annual reports by special investment purpose companies (investment companies, investment intermediaries, managing investment companies, investment funds and companies limited by shares with special purpose), with total balance value of their assets as of 31.12.2018 for 9 110 million BGN. Foreign assets received (securities and cash to customers) amounted to 5 650 million BGN.

The financial income of special purpose in companies for 2018 at current prices totalled 1 358 million BGN and the financial result for the year was a profit of 115 million BGN.

4. Associations and Foundations

According to preliminary data the number of associations and foundations, which have submitted annual reports for 2018 at the NSI, was 9 727. The balance value of their assets as of 31.12.2018 amounted to 1 186 million BGN.

The total revenues from non-profit activities for 2018 at current prices were 621 million BGN and their revenues from regular activity were 590 million BGN.




Figure 4. Balance value of assets and revenues from regular activity by years

The members of associations and foundations as of 31.12.2018 were 2 083 734, of which 174 096 were legal entities and 1 909 638 were individuals. The working volunteers were 56 736, as they worked a total of 1 432 711 hours.
