### BULGARIAN TRADE WITH THIRD COUNTRIES FOR THE PERIOD JANUARY - NOVEMBER 2011 (PRELIMINARY DATA)

In the period January - November 2011 the Bulgarian exports to third countries increased by 26.5% compared to the corresponding period of the previous year and exceeded 13.5 billion levs (Table 1.1 and 1.2). The main trade partners of Bulgaria were Turkey, Russia, Serbia, The former Yugoslav Republic of Macedonia, Ukraine, China and USA that formed 53.0% of the total exports to non EU countries (Table 2). The exports to South Africa, Canada, India and Egypt increased significantly. The most significant falls were reported on the exports to Singapore, Syria, Peru and Viet-Nam.

In November 2011 the exports to third countries increased by 6.7% compared to the corresponding month of the previous year and exceeded 1.1 billion levs.




Figure 1. Nominal growth of exports to non EU countries for the period 2009 - 2011 (Compared to the same month of the previous year)

Bulgarian imports from third countries in the first eleven months of 2011 increased by 21.8% compared to the corresponding period of the previous year and amounted to 17.1 billion levs (at CIF prices) (Tables 1.1 and 1.2). The most significant growths were reported on the imports from Kazakhstan, Singapore, United Arab Emirates and Republic of Korea (Table 2). The largest decreases were observed in the imports from Peru, Iran and Viet-Nam.

In November 2011 the Bulgarian imports from third countries increased by 7.4% compared to the corresponding month of the previous year and reached 1.7 billion levs.




Figure 2. Nominal growth of imports to non EU countries for the period

**The foreign trade balance** of Bulgaria (export FOB - import CIF) with third countries in the period January - November 2011 was negative and reached 3551.6 million levs (Table 1.1). The trade balance at FOB /FOB prices (after elimination of transport and insurance costs on imports) was also negative and amounted to 2651.1 million levs.

In **November 2011** the foreign trade balance of Bulgaria (export FOB - import CIF) with third countries was negative and reached 521.1 million levs.

The exports of Bulgaria to third countries, distributed according to the **Standard International Trade Classification**, increased in all sections in the first eleven months of 2011 compared to the corresponding period of the previous year (Table 3). The largest growths were recorded in the sections: "Crude materials, inedible (except fuel)"<sup>1</sup>, "Animal and vegetable oils, fats and waxes"<sup>2</sup> and "Mineral fuels, lubricants and related materials".

The largest growths in imports from third countries were reported in section "Chemical and related products", "Manufactured goods classified chiefly by material"<sup>3</sup> and "Mineral fuels, lubricants and related materials". Falls were reported in sections "Crude materials, inedible (except fuel)" and "Animal and vegetable oils, fats and waxes".



### Bulgarian trade with third countries and EU - total


In the period January - November 2011 the total value of the exported goods amounted to 36.2 billion levs. Compared to the corresponding period of 2010 the exports increased by 30.6% (Table 1.1 and 1.2).

In November 2011 the total exports amounted to 3.4 billion levs and increased by 19.1% compared to the corresponding month of the previous year.



The total value of all imported goods in the period January - November 2011 was 41.0 billion levs (at CIF prices), or by 20.6% more than corresponding period of the previous year (Table 1.1 and 1.2).

In November 2011 **the total imports increased by 6.0%** compared to the corresponding month of the previous year and reached 4.2 billion levs.

The total foreign trade balance (exports FOB - import CIF) was negative in the period January – November 2011 and amounted to 4822.2 million levs which was 1478.1 million levs less than the balance in the first eleven months of 2010 (Table 1.1 and 1.2). At FOB/FOB prices (after elimination of transport and insurance costs on imports) the balance was also negative and amounted to 2818.3 million levs.

In November 2011 the total foreign trade balance (**exports FOB** - **import CIF**) was negative and amounted to 765.9 million levs. The trade balance at FOB/FOB prices was also negative and reached 553.1 million levs.
