




## TRADE IN GOODS OF BULGARIA WITH THIRD COUNTRIES IN THE PERIOD JANUARY - OCTOBER 2019 (PRELIMINARY DATA)

In **the period January - October 2019 the exports** of goods from Bulgaria **to third countries** increased by 5.8% in comparison with the same period of the previous year and added up to 16 026.9 Million BGN (Annex, Tables 1 and 2). Main trade partners of Bulgaria were Turkey, China, Serbia, the United States, the Russian Federation, and the Republic of North Macedonia which accounted for 50.0% of the exports to non EU countries (Annex, Table 3).

In **October 2019** the **exports** of goods from Bulgaria **to third countries** decreased by 10.3% compared to the corresponding month of the previous year and amounted to 1 775.6 Million BGN.

In **the period January - October 2019** in the exports of goods from Bulgaria to third countries, distributed according to the **Standard International Trade Classification**, the most notable growths compared to the same period of the previous year were recorded in sections 'Food and live animals' (56.8%) and 'Mineral fuel, lubricants and related materials' (24.6%) (Annex, Table 4). The most notable fall was reported in section 'Manufactured goods classified chiefly by material'<sup>2</sup> (21.8%).

**Imports** of goods to Bulgaria **from third countries** in **the period January - October 2019** decreased by 10.7% in comparison with same period of 2018 and added up to 17 048.6 Million BGN (at CIF prices)<sup>1</sup> (Annex, Tables 1 and 2). The largest amounts were reported for the goods imported from Turkey, the Russian Federation, China and Serbia (Annex, Table 3).

In **October 2019** the imports of goods to Bulgaria from third countries decreased by 35.9% compared to the corresponding month of the previous year and amounted to 1 635.3 Million BGN.




Figure 2. Nominal value<sup>2</sup> change of imports of goods of Bulgaria from non EU countries in the period 2018 - 2019 (Compared to the same month of the previous year)

In **the period January - October 2019** in the imports of goods to Bulgaria from third countries, distributed according to the **Standard International Trade Classification**, the largest growths compared to the same period of the previous year were recorded in the sections 'Food and live animals' (23.9%) and 'Animals and vegetable oils, fats and waxes' (17.7%) (Annex, Table 4). The most notable fall was observed in sector 'Mineral fuel, lubricants and related materials' (37.9%).

**The foreign trade balance** of Bulgaria (export FOB - import CIF) with third countries in the period January - October 2019 was negative and added up to 1 021.7 Million BGN (Annex, Table 1).

In October 2019 the foreign trade balance of Bulgaria (export FOB - import CIF) with third countries was positive and amounted to 140.3 Million BGN.



## Trade in goods of Bulgaria with third countries and EU - total

In **the period January - October 2019** the total value of **all the goods exported** from Bulgaria amounted to 48 702.6 Million BGN which is 4.2% more than the same period of the previous year (Annex, Tables 1 and 2).

In **October 2019** the total exports of goods added up to 5 402.2 Million BGN and decreased by 0.8% compared to the corresponding month of the previous year.

The total value of **all the goods imported** in the country in **the period January - October 2019** amounted to 51 157.1 Million BGN (at CIF prices), or by 2.2% less than the same period of 2018 (Annex, Tables 1 and 2).

In **October 2019** the total imports of goods decreased by 11.2% compared to the same month of the previous year and added up to 5 534.1 Million BGN.





The **total foreign trade balance** (exports FOB - import CIF) was negative in the period January - October 2019 and amounted to 2 454.5 Million BGN (Annex, Tables 1 and 2).

In October 2019 the total foreign trade balance (exports FOB - import CIF) was also negative and added up to 131.9 Million BGN.


