




### TRADE IN GOODS OF BULGARIA WITH THIRD COUNTRIES IN THE PERIOD JANUARY - JUNE 2020 (PRELIMINARY DATA)

In **the period January - June 2020 the exports** of goods from Bulgaria **to third countries** decreased by 10.5% in comparison with the same period of 2019 and added up to 8 890.3 Million BGN (Annex, Tables 1 and 2). Main trade partners of Bulgaria were Turkey, China, the United Kingdom, the United States, Serbia, the Russian Federation and the Republic of North Macedonia which accounted for 54.0% of the exports to non EU countries (Annex, Table 3).

In **June 2020** the **exports** of goods from Bulgaria **to third countries** dropped by 18.1% compared to the corresponding month of the previous year and amounted to 1 378.9 Million BGN.

In **the period January - June 2020** in the exports of goods from Bulgaria to third countries, distributed according to the **Standard International Trade Classification**, the most notable growth compared to the same period of 2019 was recorded in sections 'Food and live animals' (32.6%) and 'Animals and vegetable oils, fats and waxes' (29.3%) (Annex, Table 4). The most notable fall was reported in section 'Mineral fuel, lubricants and related materials' (52.7%).






**Imports** of goods to Bulgaria **from third countries** in **the period January - June 2020** decreased by 11.0% in comparison with the same period of 2019 and added up to 10 940.8 Million BGN (at CIF prices)<sup>1</sup> (Annex, Tables 1 and 2). The largest amounts were reported for the goods imported from the Russian Federation, Turkey, China and Serbia (Annex, Table 3).

In **June 2020** the imports of goods to Bulgaria from third countries dropped by 6.2% compared to the corresponding month of the previous year and amounted to 1 803.0 Million BGN.

In **the period January - June 2020** in the imports of goods to Bulgaria from third countries, distributed according to the **Standard International Trade Classification**, the largest growth compared to the same period of 2019 was recorded in the sections 'Crude materials, inedible (except fuel)' (58.5%) and 'Animals and vegetable oils, fats and waxes' (34.5%) (Annex, Table 4). The most notable fall was observed in sector 'Mineral fuel, lubricants and related materials' (48.5%).

The foreign trade balance of Bulgaria (export FOB - import CIF) with third countries in the period January - June 2020 was negative and added up to 2 050.5 Million BGN (Annex, Table 1).


In **June 2020** the foreign trade balance of Bulgaria (export FOB - import CIF) with third countries was also negative and amounted to 424.1 Million BGN.

#### Trade in goods of Bulgaria with third countries and EU - total

In **the period January - June 2020** the total value of **all the goods exported** from Bulgaria amounted to 26 059.0 Million BGN which is 8.0% less than the same period of 2019 (Annex, Tables 1 and 2).

In **June 2020** the total exports of goods added up to 4 309.9 Million BGN and decreased by 7.2% compared to the corresponding month of the previous year.

The total value of **all the goods imported** in the country in **the period January - June 2020** amounted to 28 184.9 Million BGN (at CIF prices), or by 11.7% less than the same period of 2019 (Annex, Tables 1 and 2).



In **June 2020** the total imports of goods decreased by 6.9% compared to the same month of the previous year and added up to 4 771.5 Million BGN.

The **total foreign trade balance** (exports FOB - import CIF) was negative in the period January - June 2020 and amounted to 2 125.9 Million BGN (Annex, Tables 1 and 2).

In **June 2020** the total foreign trade balance (exports FOB - import CIF) was also negative and added up to 461.6 Million BGN.
