




TRADE IN GOODS OF BULGARIA WITH THIRD COUNTRIES IN THE PERIOD JANUARY - OCTOBER 2020 (PRELIMINARY DATA)

In **the period January - October 2020 the exports** of goods from Bulgaria **to third countries** decreased by 11.3% in comparison with the same period of 2019 and added up to 15 402.2 Million BGN (Annex, Tables 1 and 2). Main trade partners of Bulgaria were Turkey, China, the United Kingdom, the United States, Serbia, the Republic of North Macedonia and the Russian Federation, which accounted for 54.7% of the exports to non EU countries (Annex, Table 3).

In **October 2020** the **exports** of goods from Bulgaria **to third countries** dropped by 20.9% compared to the corresponding month of the previous year and amounted to 1 587.6 Million BGN.

In **the period January - October 2020** in the exports of goods from Bulgaria to third countries, distributed according to the **Standard International Trade Classification**, the most notable growth compared to the same period of 2019 was recorded in sections 'Animals and vegetable oils, fats and waxes' (41.6%) (Annex, Table 4). The most notable fall was reported in section 'Mineral fuel, lubricants and related materials' (58.1%).






Imports of goods to Bulgaria **from third countries** in **the period January - October 2020** decreased by 10.9% in comparison with the same period of 2019 and added up to 18 983.7 Million BGN (at CIF prices)¹ (Annex, Tables 1 and 2). The largest amounts were reported for the goods imported from Turkey, the Russian Federation, China and Serbia (Annex, Table 3).

In **October 2020** the imports of goods to Bulgaria from third countries dropped by 6.9% compared to the corresponding month of the previous year and amounted to 2 214.6 Million BGN.

In **the period January - October 2020** in the imports of goods to Bulgaria from third countries, distributed according to the **Standard International Trade Classification**, the largest growth compared to the same period of 2019 was recorded in the sections 'Crude materials, inedible (except fuel)' (90.2%) and 'Animals and vegetable oils, fats and waxes' (63.2%) (Annex, Table 4). The most notable fall was observed in sector 'Mineral fuel, lubricants and related materials' (51.2%).

The foreign trade balance of Bulgaria (export FOB - import CIF) with third countries in the period January - October 2020 was negative and added up to 3 581.5 Million BGN (Annex, Table 1).


In **October 2020** the foreign trade balance of Bulgaria (export FOB - import CIF) with third countries was also negative and amounted to 627.0 Million BGN.

Trade in goods of Bulgaria with third countries and EU - total

In **the period January - October 2020** the total value of **all the goods exported** from Bulgaria amounted to 45 162.4 Million BGN which is 7.6% less than the same period of 2019 (Annex, Tables 1 and 2).

In **October 2020** the total exports of goods added up to 4 907.6 Million BGN and decreased by 10.8% compared to the corresponding month of the previous year.

The total value of **all the goods imported** in the country in **the period January - October 2020** amounted to 48 803.0 Million BGN (at CIF prices), or by 10.9% less than the same period of 2019 (Annex, Tables 1 and 2).


In **October 2020** the total imports of goods decreased by 10.3% compared to the same month of the previous year and added up to 5 558.1 Million BGN.

The **total foreign trade balance** (exports FOB - import CIF) was negative in **the period January - October 2020** and amounted to 3 640.6 Million BGN (Annex, Tables 1 and 2).

In **October 2020** the total foreign trade balance (exports FOB - import CIF) was also negative and added up to 650.5 Million BGN.
