


### TRADE IN GOODS OF BULGARIA WITH THIRD COUNTRIES IN THE PERIOD JANUARY - JULY 2022 (PRELIMINARY DATA)

In **the period January - July 2022, the exports** of goods from Bulgaria **to third countries** increased by 36.6% in comparison with the same period of 2021 and added up to 17 772.2 million BGN (Annex, Tables 1 and 2). The main trade partners of Bulgaria were Turkey, Serbia, the United States, Ukraine, the Republic of North Macedonia, the United Kingdom and China, which accounted for 51.1% of the exports to non-EU countries (Annex, Table 3).

In **July 2022**, the **exports** of goods from Bulgaria **to third countries** increased by 27.3% compared to the corresponding month of the previous year and amounted to 2 584.6 million BGN.

In **the period January - July 2022**, in the exports of goods from Bulgaria to third countries, distributed according to the **Standard International Trade Classification**, the most notable growth compared to the same period of 2021 was recorded in the sections 'Mineral fuel, lubricants and related materials' (228.7%) and 'Animal and vegetable oils, fats and waxes' (69.7%) (Annex, Table 4). Fall was reported in the section 'Manufactured goods classified chiefly by material'<sup>2</sup> (12.9%).

**Imports** of goods to Bulgaria **from third countries** in **the period January - July 2022** increased by 67.5% in comparison with the same period of 2021 and added up to 27 696.4 million BGN (at CIF prices)<sup>1</sup> (Annex, Tables 1 and 2). The largest amounts were reported for the goods imported from the Russian Federation, Turkey, China and Ukraine (Annex, Table 3).

In **July 2022**, the imports of goods to Bulgaria from third countries increased by 89.5% compared to the corresponding month of the previous year and amounted to 4 555.5 million BGN.




Figure 2. Nominal value<sup>2</sup> change of imports of goods to Bulgaria from non-EU countries in the period 2021 - 2022 (Compared to the same month of the previous year)

In **the period January - July 2022**, in the imports of goods to Bulgaria from third countries, distributed according to the **Standard International Trade Classification**, the largest growth compared to the same period of 2021 was recorded in the sections 'Animal and vegetable oils, fats and waxes' (335.1%) and 'Mineral fuel, lubricants and related materials' (151.7%) (Annex, Table 4).

**The foreign trade balance** of Bulgaria (exports FOB - imports CIF) with third countries in **the period January - July 2022** was negative and added up to 9 924.2 million BGN (Annex, Table 1).

In **July 2022**, the foreign trade balance of Bulgaria (exports FOB - imports CIF) with third countries was also negative and amounted to 1 970.9 million BGN.






### Trade in goods of Bulgaria with third countries and the EU – total

In **the period January - July 2022**, the total value of **all the goods exported** from Bulgaria amounted to 54 288.1 million BGN, which is 41.7% more than the same period of 2021 (Annex, Tables 1 and 2).

In **July 2022, the total exports** of goods added up to 8 065.9 million BGN and increased by 37.6% compared to the corresponding month of the previous year.






The total value of **all the goods imported** into the country in **the period January - July 2022** amounted to 61 649.2 million BGN (at CIF prices), or 46.5% more than in the same period of 2021 (Annex, Tables 1 and 2).

In **July 2022**, the total imports of goods increased by 53.5% compared to the same month of the previous year and added up to 9 750.1 million BGN.

**The total foreign trade balance** (exports FOB - imports CIF) was negative in **the period January - July 2022** and amounted to 7 361.1 million BGN (Annex, Table 1).

In **July 2022**, the total foreign trade balance (exports FOB - imports CIF) was also negative and added up to 1 684.2 million BGN.
