


## TRADE IN GOODS OF BULGARIA WITH THIRD COUNTRIES IN THE PERIOD JANUARY - OCTOBER 2022 (PRELIMINARY DATA)

In **the period January - October 2022, the exports** of goods from Bulgaria **to third countries** increased by 37.0% in comparison with the same period of 2021 and added up to 26 203.3 million BGN (Annex, Tables 1 and 2). The main trade partners of Bulgaria were Turkey, Serbia, Ukraine, the United States, the Republic of North Macedonia, the United Kingdom and China, which accounted for 51.5% of the exports to non-EU countries (Annex, Table 3).

In **October 2022**, the **exports** of goods from Bulgaria **to third countries** increased by 35.1% compared to the corresponding month of the previous year and amounted to 2 620.2 million BGN.

In **the period January - October 2022**, in the exports of goods from Bulgaria to third countries, distributed according to the **Standard International Trade Classification**, the most notable growth compared to the same period of 2021 was recorded in the sections 'Mineral fuel, lubricants and related materials' (228.2%) and 'Animal and vegetable oils, fats and waxes' (138.8%) (Annex, Table 4). A fall was reported in the section 'Manufactured goods classified chiefly by material'<sup>2</sup> (5.4%).





**Imports** of goods to Bulgaria **from third countries** in **the period January - October 2022** increased by 66.6% in comparison with the same period of 2021 and added up to 40 825.6 million BGN (at CIF prices)<sup>1</sup> (Annex, Tables 1 and 2). The largest amounts were reported for the goods imported from the Russian Federation, Turkey, China and Ukraine (Annex, Table 3).

In **October 2022, the imports** of goods to Bulgaria **from third countries** increased by 63.4% compared to the corresponding month of the previous year and amounted to 4 497.3 million BGN.





In **the period January - October 2022**, in the imports of goods to Bulgaria from third countries, distributed according to the **Standard International Trade Classification**, the largest growth compared to the same period of 2021 was recorded in the sections 'Animal and vegetable oils, fats and waxes' (478.9%) and 'Mineral fuel, lubricants and related materials' (146.7%) (Annex, Table 4).

**The foreign trade balance** of Bulgaria (exports FOB - imports CIF) with third countries in **the period January - October 2022** was negative and added up to 14 622.3 million BGN (Annex, Table 1).

In **October 2022**, the foreign trade balance of Bulgaria (exports FOB - imports CIF) with third countries was also negative and amounted to 1 877.1 million BGN.






## Trade in goods of Bulgaria with third countries and the EU - total

In **the period January - October 2022**, the total value of **all the goods exported** from Bulgaria amounted to 79 004.3 million BGN, which is 40.8% more than the same period of 2021 (Annex, Tables 1 and 2).

In **October 2022, the total exports** of goods added up to 8 255.6 million BGN and increased by 34.0% compared to the corresponding month of the previous year.







The total value of **all the goods imported** into the country in **the period January - October 2022** amounted to 90 204.5 million BGN (at CIF prices), or 45.9% more than in the same period of 2021 (Annex, Tables 1 and 2).

In **October 2022, the total imports** of goods increased by 42.6% compared to the same month of the previous year and added up to 9 810.3 million BGN.

**The total foreign trade balance** (exports FOB - imports CIF) was negative in **the period January** - **October 2022** and amounted to 11 200.2 million BGN (Annex, Table 1).

In **October 2022**, the total foreign trade balance (exports FOB - imports CIF) was also negative and added up to 1 554.7 million BGN.
