
TRADE IN GOODS OF BULGARIA WITH THIRD COUNTRIES IN THE PERIOD JANUARY - AUGUST 2023 (PRELIMINARY DATA)

In the period January - August 2023, the exports of goods from Bulgaria to third countries decreased by 9.5% in comparison with the same period of 2022 and added up to 19 316.6 million BGN (Annex, Tables 1 and 2). The main trade partners of Bulgaria were Türkiye, the United States, Serbia, Ukraine, China, the Republic of North Macedonia and the United Kingdom, which accounted for 51.5% of the exports to non-EU countries (Annex, Table 3).

In **August 2023**, the **exports** of goods from Bulgaria **to third countries** decreased by 40.4% compared to the corresponding month of the previous year and amounted to 1 723.8 million BGN.

In **the period January - August 2023**, in the exports of goods from Bulgaria to third countries, distributed according to the **Standard International Trade Classification**, the most notable growth compared to the same period of 2022 was recorded in the sections 'Machinery and transport equipment' (15.6%) and 'Beverages and tobacco' (12.3%) (Annex, Table 4). The most notable fall was reported in the section 'Mineral fuel, lubricants and related materials' (38.5%).



Imports of goods to Bulgaria **from third countries** in **the period January - August 2023** decreased by 18.9% in comparison with the same period of 2022 and added up to 25 387.9 million BGN (at CIF prices)¹ (Annex, Tables 1 and 2). The largest amounts were reported for the goods imported from Türkiye, the Russian Federation, China and Serbia (Annex, Table 3).

In August 2023, the imports of goods to Bulgaria **from third countries** decreased by 11.4% compared to the corresponding month of the previous year and amounted to 3 376.1 million BGN.

In **the period January - August 2023**, in the imports of goods to Bulgaria from third countries, distributed according to the **Standard International Trade Classification**, the largest growth compared to the period January - August 2022 was recorded in the sections 'Food and live animals' (17.5%) and 'Beverages and tobacco' (16.9%) (Annex, Table 4). The most notable fall was reported in the section 'Animal and vegetable oils, fats and waxes' (38.1%).

The foreign trade balance of Bulgaria (exports FOB - imports CIF) with third countries in the period January - August 2023 was negative and added up to 6 071.3 million BGN (Annex, Table 1).

In **August 2023**, the foreign trade balance of Bulgaria (exports FOB - imports CIF) with third countries was also negative and amounted to 1 652.3 million BGN.





Trade in goods of Bulgaria with third countries and the EU - total

In **the period January - August 2023**, the total value of **all the goods exported** from Bulgaria amounted to 56 841.6 million BGN, which is 7.6% less than the corresponding period of the previous year (Annex, Tables 1 and 2).

In **August 2023**, the total exports of goods added up to 6 094.7 million BGN and decreased by 22.0% compared to the corresponding month of the previous year.






The total value of **all the goods imported** into the country in **the period January - August 2023** amounted to 63 877.1 million BGN (at CIF prices), or 8.8% less than in the period January - August 2022 (Annex, Tables 1 and 2).

In **August 2023**, the total imports of goods decreased by 8.0% compared to the same month of the previous year and added up to 7 856.7 million BGN.

The total foreign trade balance (exports FOB - imports CIF) was negative in the period January - August 2023 and amounted to 7 035.5 million BGN (Annex, Table 1).

In August 2023, the total foreign trade balance (exports FOB - imports CIF) was also negative and added up to 1 762.0 million BGN.
