




## TRADE IN GOODS OF BULGARIA WITH EU IN THE PERIOD JANUARY - MAY 2021 (PRELIMINARY DATA)

In the period **January - May 2021 the exports of goods** from Bulgaria **to the EU** increased by 23.4% in comparison with the same period of 2020 and added up to 17 616.9 million BGN (Annex, Tables 1 and 2). Main trade partners of Bulgaria were Germany, Romania, Italy, Greece, Belgium and France, which accounted for 70.5% of the exports to the EU Member States (Annex, Table 3).

In **May 2021** the exports to the EU grew by 31.4% compared to the corresponding month of the previous year and amounted to 3 363.2 million BGN.

In the period **January - May 2021** in the exports of goods from Bulgaria to the EU, distributed according to the **Standard International Trade Classification**, the most notable growth compared to the same period of 2020 was recorded in sections 'Animal and vegetable oils, fats and waxes' (153.2%) and 'Crude materials, inedible (except fuel)'<sup>2</sup> (39.4 %) (Annex, Table 4). Fall was not reported in any of the sections.






**Imports of goods** to Bulgaria **from the EU** in the period **January - May 2021** increased by 25.0% in comparison with the same period of 2020 and added up to 17 879.5 million BGN (at CIF prices)<sup>1</sup> (Annex, Tables 1 and 2). The largest amounts were reported for the goods imported from Germany, Romania, Italy, Greece, the Netherlands and Hungary (Annex, Table 3).

Census

In **May 2021** the Bulgarian imports from the EU Member States grew by 50.4% compared to the corresponding month of the previous year and amounted to 3 682.7 million BGN.

In the period **January - May 2021** in the imports of goods to Bulgaria from the EU Member States, distributed according to the **Standard International Trade Classification**, the largest growth compared to the corresponding period of 2020 was recorded in the section 'Animal and vegetable oils, fats and waxes' (76.6%). Fall was not observed in any of the sections.

The foreign trade balance of Bulgaria (export FOB - import CIF) with the EU in the period January - May 2021 was negative and added up to 262.6 million BGN (Annex, Table 1).
