




# TRADE IN GOODS OF BULGARIA WITH EU IN THE PERIOD JANUARY - JULY 2021 (PRELIMINARY DATA)

In the period **January - July 2021 the exports of goods** from Bulgaria **to the EU** increased by 23.0% in comparison with the same period of 2020 and added up to 25 258.2 million BGN (Annex, Tables 1 and 2). Main trade partners of Bulgaria were Germany, Romania, Italy, Greece, France and Belgium which accounted for 69.8% of the exports to the EU Member States (Annex, Table 3).

In **July 2021** the exports to the EU grew by 16.1% compared to the corresponding month of the previous year and amounted to 3 832.0 million BGN.

In the period **January - July 2021** in the exports of goods from Bulgaria to the EU, distributed according to the **Standard International Trade Classification**, the most notable growth compared to the same period of 2020 was recorded in sections 'Animals and vegetable oils, fats and waxes' (137.7%) and 'Crude materials, inedible (except fuel)'<sup>2</sup> (31.5%) (Annex, Table 4). Fall was reported only in the section 'Beverages and tobacco' (11.3%).



**Imports** of goods to Bulgaria **from the EU** in the period **January - July 2021** increased by 25.3% in comparison with the same period of 2020 and added up to 25 551.7 million BGN (at CIF prices)<sup>1</sup> (Annex, Tables 1 and 2). The largest amounts were reported for the goods imported from Germany, Romania, Italy, Greece, the Netherlands and Hungary (Annex, Table 3).

In **July 2021** the Bulgarian imports from the EU Member States grew by 26.4% compared to the corresponding month of the previous year and amounted to 3 950.2 million BGN.

In the period **January - July 2021** in the imports of goods to Bulgaria from the EU Member States, distributed according to the **Standard International Trade Classification**, the largest growth compared to the corresponding period of 2020 was recorded in the section 'Animals and vegetable oils, fats and waxes' (101.1%). Fall was not observed in any of the sections.

The foreign trade balance of Bulgaria (export FOB - import CIF) with the EU in the period January - July 2021 was negative and added up to 293.5 million BGN (Annex, Table 1).
