





BULGARIA AND EU: GROSS DOMESTIC PRODUCT, FOURTH QUARTER OF 2019 (FLASH ESTIMATES)

Gross Domestic Product (GDP) in the fourth quarter of 2019 increased by 0.1% in the EU-27 compared to the previous quarter by seasonally adjusted data. For the same period, GDP in Bulgaria increased by 0.7% (Table 1 of the Annex).

Compared to the previous quarter, in the fourth quarter of 2019, Romania recorded the highest economic growth - 1.5%, Lithuania - 1.3%, Hungary - 1.0% and Cyprus - 0.8%. France, Italy and Finland reported a decrease of 0.1%, 0.3% and 0.4% respectively.



Compared to the same quarter of the previous year, seasonally adjusted data showed an increase of GDP in the EU-27 by 1.2% and in Bulgaria - by 3.5%.

In the fourth quarter of 2019, compared to the same quarter of the previous year, the highest economic growth is observed in Hungary - 4.6%, Romania - 4.2 and Lithuania - 3.7%.
