

PRODUCER PRICE INDEXES IN INDUSTRY¹ MARCH 2009

1. Producer Price Indexes on domestic market²

Producer Price Index on Domestic Market in March 2009 rose 1.1 per cent compared to the previous month. In mining and quarrying industry prices increased by 2.7 per cent, in electricity, gas, steam and air conditioning supply prices by 2.3 per cent, in manufacturing industry by 0.3 per cent. The more significant increases of prices in manufacturing industry were: 4.1 per cent in manufacture of chemicals and chemical products, 1.4 per cent in manufacture of tobacco products. The prices in manufacture of basic metals fell by 2.5 per cent, in repair and installation of machinery and equipment by 2.4 per cent. In mining and quarrying industry between February to March producer prices in mining of metal ores rose 5.9 per cent.

Producer Price Index on Domestic Market in March 2009 decreased by 1.1 per cent comparing to the same month of 2008. In manufacturing industry, prices fell by 10.0 per cent comparing to March 2008, while in electricity, gas, steam and air conditioning supply prices increased by 25.8 per cent.


In manufacturing industry comparing to the same month of 2008 the prices decreased in manufacture of basic metals by 29.8 per cent, in manufacture of food products by 4.1 per cent, in manufacture of computer, electronic and optical products by 3.5 per cent, in manufacture of rubber and plastic products by 3.1 per cent. The prices rose 11.6 per cent in manufacture of beverages, 10.6 per cent in manufacture of fabricated metal products, except machinery and equipment, 8.3 per cent in manufacture of chemicals and chemical products.


Producer price indexes measure the average change in the prices of industrial products, which are produced and sold by Bulgarian enterprises. They can be considered as an early measure of the current inflation process in the economy and also they can be used for international comparisons. Information for calculation of Producer price indexes is received on the bases of monthly surveys on producer prices of industrial products, sold on domestic market and on industrial products sold on non-domestic market. Producer price surveys are based on constant sample of groups of products, and that sample is representative for total industrial production.

¹ Since January 2009, Producer Price Indexes are calculated according to the new Classification of Economic Activities NACE.BG 2008. At the same time, the base year has been changed and indexes are calculated at 2005 as a base year. Historical data series have been recalculated back to 2000 and they are posted in NSI web-site (http://www.nsi.bg/Index_e.htm).

² Producer price indexes on domestic market are calculated at constant base (2005) weighed with turnover structure on domestic market.







2. Total Producer Price Indexes in Industry³

Total Producer Price Index in industry in March 2009 increased by 0.2 per cent compared with February 2009, in manufacturing industry prices increased by 0.1 per cent and in electricity, gas, steam and air conditioning supply by 0.9 per cent. The prices rose 2.9 per cent in manufacture of basic pharmaceutical products and pharmaceutical preparations, 2.0 per cent in manufacture of chemicals and chemical products, while comparing to February the prices fell by 2.2 per cent in repair and installation of machinery and equipment, by 1.2 per cent in manufacture of motor vehicles, trailers and semi-trailers.


Total Producer Price Index in March 2009 Γ . decreased by 5.5 per cent comparing to the same month of 2008.

In manufacturing industry producer prices in March 2009 compared to the March 2008 decreased by 11.8 per cent, while in electricity, gas, steam and air conditioning supply prices increased by 21.5 per cent. In manufacturing industry more significant price decrease by 35.3 per cent was registered in manufacture of basic metals.

³ Total producer price index is calculated from Producer price index on domestic market and Producer price index on non-domestic market weighted with the turnover structure on domestic and on non-domestic market to the total value of turnover in the base year 2005.
