



### PRODUCER PRICE INDICES IN INDUSTRY<sup>1,2</sup>, MAY 2020

## 1. Total Producer Price Indices in Industry<sup>3</sup>

The Total Producer Price Index in Industry in May 2020 decreased by 1.0% compared to the previous month. Lower prices were registered in the electricity, gas, steam and air conditioning supply by 1.4%, and in manufacturing by 1.0%, while higher prices were registered in the mining and quarrying industry by 0.8%.

In manufacturing, prices went down in the manufacture of basic metals by 6.8%, in the manufacturing of chemicals and chemical products and in the manufacturing of tobacco products - both by 1.0%. More significant increase in prices was reported in the manufacture of paper and paper products by 0.9%, and in the repair and installation of machinery and equipment by 0.4%.

The Total Producer Price Index in May 2020 decreased by 5.3% compared to the same month of 2019. The prices fell in manufacturing by 7.0%, in the mining and quarrying industry by 2.2%, and in the electricity, gas, steam and air conditioning supply by 0.3%.

In manufacturing, significant decrease in prices were seen in the manufacture of basic metals by 10.2%, in the manufacture of wood and of products of wood and cork, except furniture and manufacture of articles of straw and plaiting materials by 3.5% and in the manufacture of paper and paper products by 3.3%. More compelling increase in prices was reported in the manufacture of food products by 3.9%, in the manufacture of leather and related products and in the manufacture of furniture - both by 2.7%.

<sup>&</sup>lt;sup>1</sup> Producer Price Indices measure the average change in the prices of industrial products, which are produced and sold by Bulgarian enterprises. They can be considered as an early measure of the current inflation process in the economy and also they can be used for international comparisons. Information for calculation of Producer Price Indices is received on the bases of monthly surveys on producer prices of industrial products, sold on domestic market and on industrial products sold on non-domestic market. Producer price surveys are based on constant sample of groups of products, and that sample is representative for total industrial production.



<sup>&</sup>lt;sup>3</sup> Total Producer Price Indices are calculated from Producer Price Indices on Domestic Market and Producer Price Indices on Nondomestic Market weighted with the turnover structure on domestic and on non-domestic market to the total value of turnover in the base year (2015).

#### 2. Producer Price Indices on Domestic Market<sup>1</sup>

**Producer Price Index on Domestic Market** in May 2020 decreased by 0.6% compared to the previous month. The domestic prices went down in the electricity, gas, steam and air conditioning supply by 1.1%, in and in manufacturing by 0.4%, while the prices grew in the mining and quarrying industry by 0.7%.

In the manufacturing, compared to the previous month the prices went down more compellingly in the manufacture of chemicals and chemical products by 1.4%, and in the manufacture of electrical equipment by 0.7%. More significant increase in the domestic prices was seen in the manufacture of motor vehicles, trailers and semi-trailers by 3.2% and in the manufacture of basic metals by 1.0%.

**Producer Price Index on Domestic Market** in May 2020 decreased by 1.6% compared to the same month of 2019. Prices went down in the mining and quarrying industry by 5.3% and in manufacturing by 3.4%, while the prices rose in the electricity, gas, steam and air conditioning supply by 1.4%.

In manufacturing compered to May 2019, the prices fell in the manufacture of basic metals by 7.8% and in the manufacture of paper and paper products by 2.1%. More compelling price increase was reported in the manufacture of motor vehicles, trailers and semi-trailers by 5.2% and in the manufacture of food products by 5.1%.




Figure 2. Producer Price Indices on Domestic Market in Industry (2015 = 100)

#### 3. Producer Price Indices on Non-domestic Market<sup>1</sup>

**Producer Price Index on Non-domestic Market** in May 2020 fell by 1.7% compared to the previous month and by 10.7% compared to the same month of 2019.
