

PRODUCER PRICE INDICES IN INDUSTRY^{1,2}, OCTOBER 2020

1. Total Producer Price Indices in Industry³

The Total Producer Price Index in Industry in October 2020 increased by 0.3% compared to the previous month. Higher prices were registered in mining and quarrying industry by 2.1%, the electricity, gas, steam and air conditioning supply by 0.9%, and in manufacturing by 0.1%.

Prices went up significantly in the manufacture of tobacco products by 1.4% and in manufacture of leather and related products by 0.7%. Prices fell in the manufacture of wood and of products of wood and cork, except furniture; manufacture of articles of straw and plaiting materials, in the manufacture of basic metals - all by 0.7%, and in the manufacture of rubber and plastic products by 0.4%.

The Total Producer Price Index in October 2020 decreased by 2.7% compared to the same month of 2019. The prices fell in manufacturing by 3.5%, in the electricity, gas, steam and air conditioning supply by 2.5%, while in the mining and quarrying industry the prices rose by 12.5%.

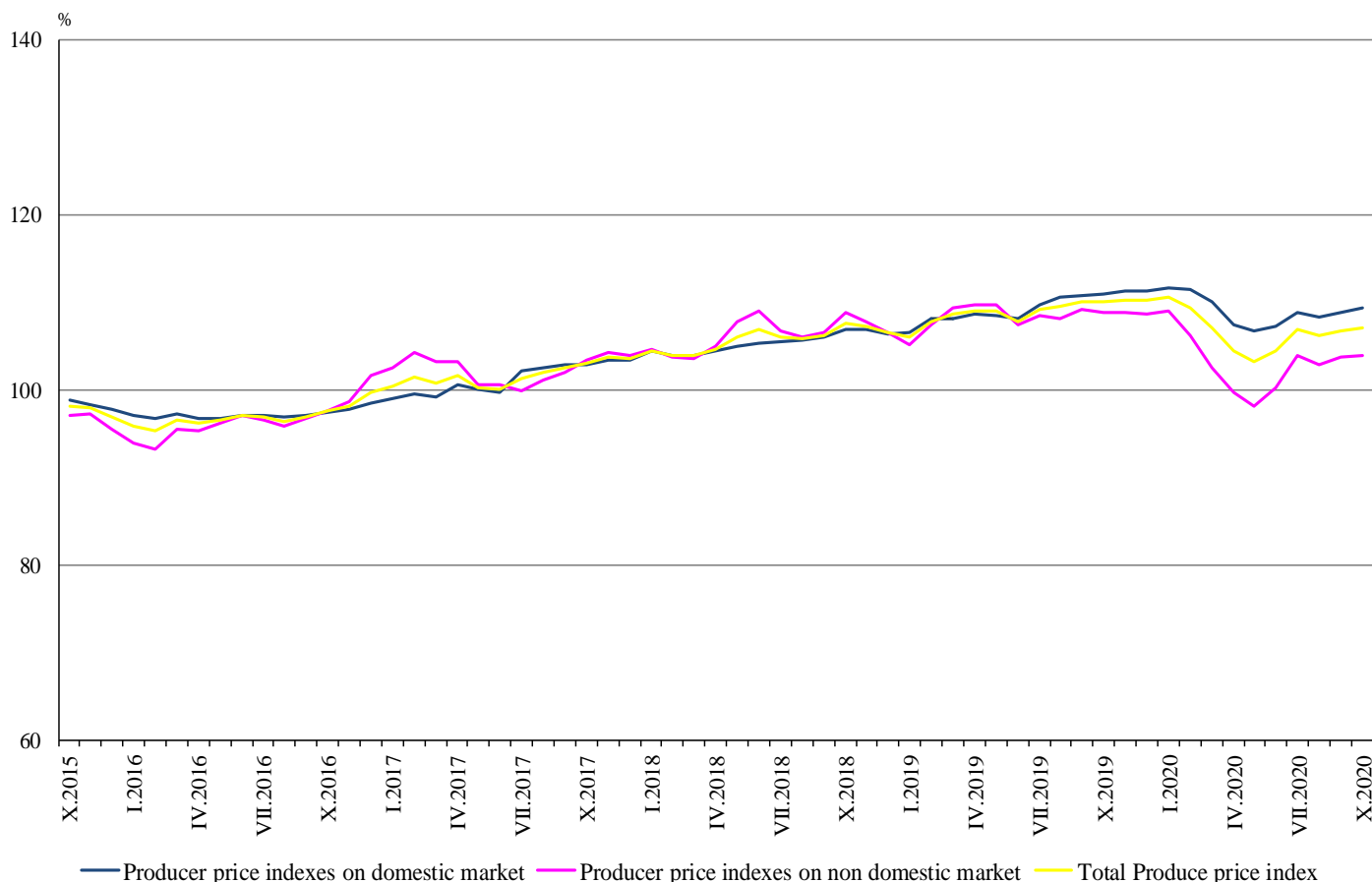
In manufacturing, significant decreases in prices were seen in the manufacture of wood and of products of wood and cork, except furniture; manufacture of articles of straw and plaiting materials by 3.8%, in the manufacture of paper and paper products, and in the manufacture of rubber and plastic products - all by 1.9%. More compelling increase in prices was reported in the manufacture of food products by 3.1%, in the manufacture of tobacco products by 2.8%, and in the manufacture of leather and related products by 2.6%.

¹ Producer Price Indices measure the average change in the prices of industrial products, which are produced and sold by Bulgarian enterprises. They can be considered as an early measure of the current inflation process in the economy and also they can be used for international comparisons. Information for calculation of Producer Price Indices is received on the bases of monthly surveys on producer prices of industrial products, sold on domestic market and on industrial products sold on non-domestic market. Producer price surveys are based on constant sample of groups of products, and that sample is representative for total industrial production.

² In the text are not quoted the activities that are confidential according to the Law on Statistics and in this way they are statistical secrecy.

³ Total Producer Price Indices are calculated from Producer Price Indices on Domestic Market and Producer Price Indices on Non-domestic Market weighted with the turnover structure on domestic and on non-domestic market to the total value of turnover in the base year (2015).

2. Producer Price Indices on Domestic Market¹

Producer Price Index on Domestic Market in October 2020 increased by 0.4% compared to the previous month. The domestic prices went up in the mining and quarrying industry by 1.2% and in the electricity, gas, steam and air conditioning supply by 0.5% and in the manufacturing by 0.3%.

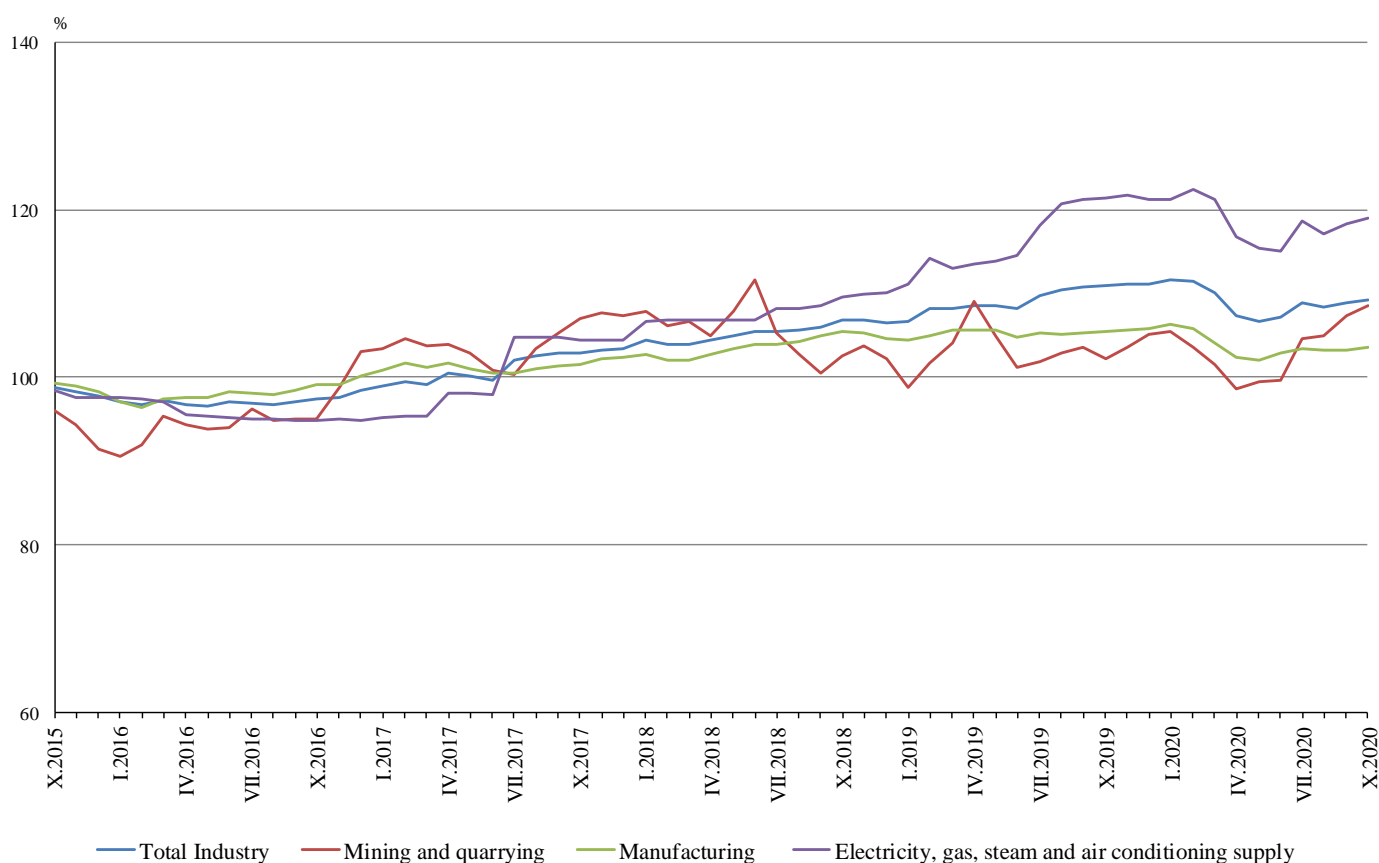
In the manufacturing, compared to the previous month prices went up in the manufacture of chemicals and chemical products, in the manufacture of other transport equipment - all by 1.0% and in manufacture of computer, electronic and optical products by 0.7%. The prices went down in the manufacture of motor vehicles, trailers and semi-trailers by 1.2%, and in manufacture of wood and of products of wood and cork, except furniture; manufacture of articles of straw and plaiting materials by 1.1%.

¹ Producer Price Indices on domestic market are calculated at constant base (2015) weighed with turnover structure on domestic market.

Producer Price Index on Domestic Market in October 2020 decreased by 1.5% compared to the same month of 2019. Prices went down in the electricity, gas, steam and air conditioning supply by 2.0% and in manufacturing by 1.8%, while the prices rose in the mining and quarrying industry by 6.3%.

In manufacturing compared to October 2019, the prices fell in the manufacture of wood and of products of wood and cork, except furniture; manufacture of articles of straw and plaiting materials by 2.5% and in manufacture of paper and paper products by 1.5%. More compelling price increase was reported in the manufacture of food products by 3.7% and in manufacture of leather and related products by 3.4%.

3. Producer Price Indices on Non-domestic Market¹

Producer Price Index on Non-domestic Market in October 2020 increased by 0.2% compared to the previous month and decreased by 4.5% compared to the same month of 2019.

¹ Producer Price Indices on non-domestic market are calculated at constant base (2015) weighed with turnover structure on non-domestic market.
