

## PRODUCER PRICE INDICES IN INDUSTRY<sup>1,2</sup>, NOVEMBER 2022

#### 1. Total Producer Price Indices in Industry<sup>3</sup>

**The Total Producer Price Index in Industry** decreased by 9.5% in November 2022 compared to the previous month. Lower prices were registered in the electricity, gas, steam and air conditioning supply by 23.3%, in the manufacturing by 0.7%, and in the mining and quarrying industry by 0.6%.

In manufacturing, prices went down in the manufacture of chemicals and chemical products by 5.9%, in the manufacture of basic metals by 3.1%, and in the manufacture of wood and of products of wood and cork, except furniture; manufacture of articles of straw and plaiting materials by 1.1%.

The prices increase in the manufacture of leather and related products by 4.9%, in the manufacture of furniture by 3.1%, and in the manufacture of other non-metallic mineral products by 3.0%.

**The Total Producer Price Index** rose by 21.2% in November 2022 compared to the same month in 2021. Significant growth was seen in the electricity, gas, steam and air conditioning supply by 30.5%, in the manufacturing by 17.8%, and in the mining and quarrying industry by 2.5%.


In manufacturing, the most significant increase in prices was reported in the manufacture of other nonmetallic mineral products by 28.5%, in the manufacture of wood and of products of wood and cork, except furniture; manufacture of articles of straw and plaiting materials by 28.4%, in the manufacture of paper and paper products by 28.2%, and in the manufacture of food products by 27.2%. The prices went down in the manufacture of basic metals by 6.5%.

<sup>&</sup>lt;sup>1</sup> Producer Price Indices measure the average change in the prices of industrial products, which are produced and sold by Bulgarian enterprises. They can be considered an early measure of the current inflation process in the economy and they can be used for international comparisons. Information for calculation of Producer Price Indices is received on the basis of monthly surveys on producer prices of industrial products sold on the domestic market and on industrial products sold on the non-domestic market. Producer price surveys are based on a constant sample of groups of products, and that sample is representative of total industrial production.

 $<sup>^{2}</sup>$  The text does not quote the activities that are confidential according to the Law on Statistics and in this way they are statistical secrecy.

<sup>&</sup>lt;sup>3</sup> Total Producer Price Indices are calculated from Producer Price Indices on Domestic Market and Producer Price Indices on the Non-domestic Market weighted with the turnover structure on the domestic and the non-domestic market to the total value of turnover in the base year (2015).

#### 2. Producer Price Indices on Domestic Market<sup>1</sup>

**The Producer Price Index on the Domestic Market** decreased by 12.6% in November 2022 compared to the previous month. The domestic prices went down in the electricity, gas, steam and air conditioning supply by 23.1%, in the mining and quarrying industry by 2.1%, and in the manufacturing by 0.9%.

In manufacturing, compared to the previous month, prices went down in the manufacture of chemicals and chemical products by 7.5%, in the manufacture of basic metals by 3.9%, and in the manufacture of wood and of products of wood and cork, except furniture; manufacture of articles of straw and plaiting materials by 1.5%.


Prices increased in the manufacture of leather and related products by 11.2%, in the manufacture of furniture by 4.2%, and in the manufacture of other non-metallic mineral products by 2.2%.

**The Producer Price Index on the Domestic Market** went up by 25.3% compared to November 2021. Prices rose in the electricity, gas, steam and air conditioning supply by 28.1%, in manufacturing by 24.3%, and in the mining and quarrying industry by 6.1%.

In manufacturing, compared to November 2021, a more compelling price increase was reported in the manufacture of wood and of products of wood and cork, except furniture; manufacture of articles of straw and plaiting materials by 39.6%, in the manufacture of other non-metallic mineral products by 33.2%, in the manufacture of chemicals and chemical products by 28.6%, and in the manufacture of food products by 28.2%.

#### 3. Producer Price Indices on Non-domestic Market<sup>1</sup>

**The Producer Price Index on the Non-domestic market** decreased by 3.0% in November 2022 compared to the previous month, while compared to the same month of 2021, the prices rose by 14.2%.

<sup>&</sup>lt;sup>1</sup> Producer Price Indices on the non-domestic market are calculated at a constant base (2015) weighed with the turnover structure on the non-domestic market.
