



PRODUCER PRICE INDICES IN INDUSTRY, JUNE 2024

1. Total Producer Price Indices in Industry

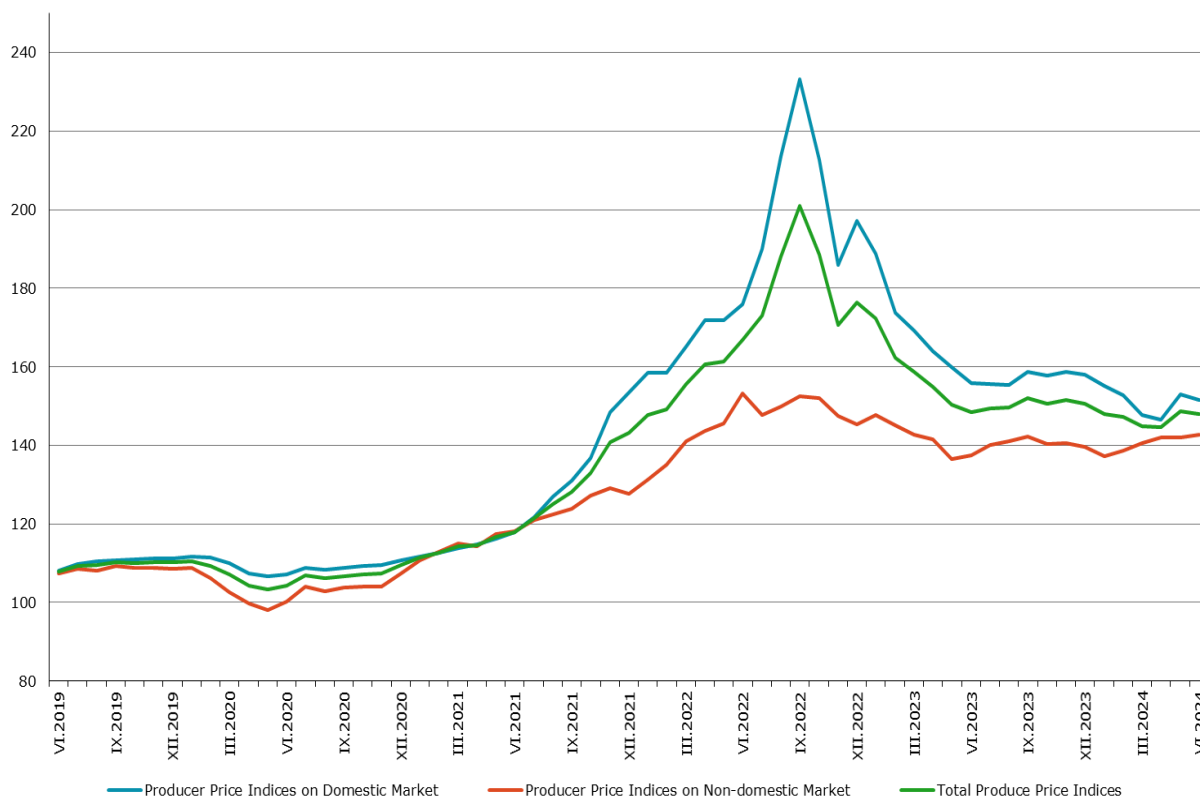
The Total Producer Price Index in Industry fell by 0.4% in June 2024 compared to the previous month. Drop of 2.2% was registered in the mining and quarrying industry, in the electricity, gas, steam and air conditioning supply - by 0.6%, and in the manufacturing industry - by 0.2%.

Lower prices in the manufacturing industry were observed in the manufacture of basic metals - by 1.8%, in the manufacture of leather and related products and in the manufacture of wood and of products of wood and cork, except furniture; manufacture of articles of straw and plaiting materials - both by 1.0%. An increase was seen in the manufacture of motor vehicles, trailers and semi-trailers - by 2.7%.

The Total Producer Price Index went down by 0.3% in June 2024 compared to the same month in 2023. There was a considerable decline of the prices in the electricity, gas, steam and air conditioning supply - by 10.7%. An increase was observed in the mining and quarrying industry - by 11.0%, and in the manufacturing industry - by 2.6%.

In the manufacturing, prices grew in the manufacture of rubber and plastic products - by 10.7%, in the manufacture of computer, electronic and optical products - by 9.5%, and in the manufacture of basic metals - by 9.3%. Considerable decrease was registered in the manufacture of leather and related products - by 10.4%, in the manufacture of wood and of products of wood and cork, except furniture; manufacture of articles of straw and plaiting materials - by 8.4%, and in the manufacture of basic pharmaceutical products and pharmaceutical preparations - by 5.6%.

2. Producer Price Indices on Domestic Market

The Producer Price Index on the Domestic Market went down by 0.9% in June 2024 compared to May 2024. The domestic prices decreased in the electricity, gas, steam and air conditioning supply - by 2.8%, while in the manufacturing industry increased - by 0.1%, the mining and quarrying industry kept the level of the previous month.

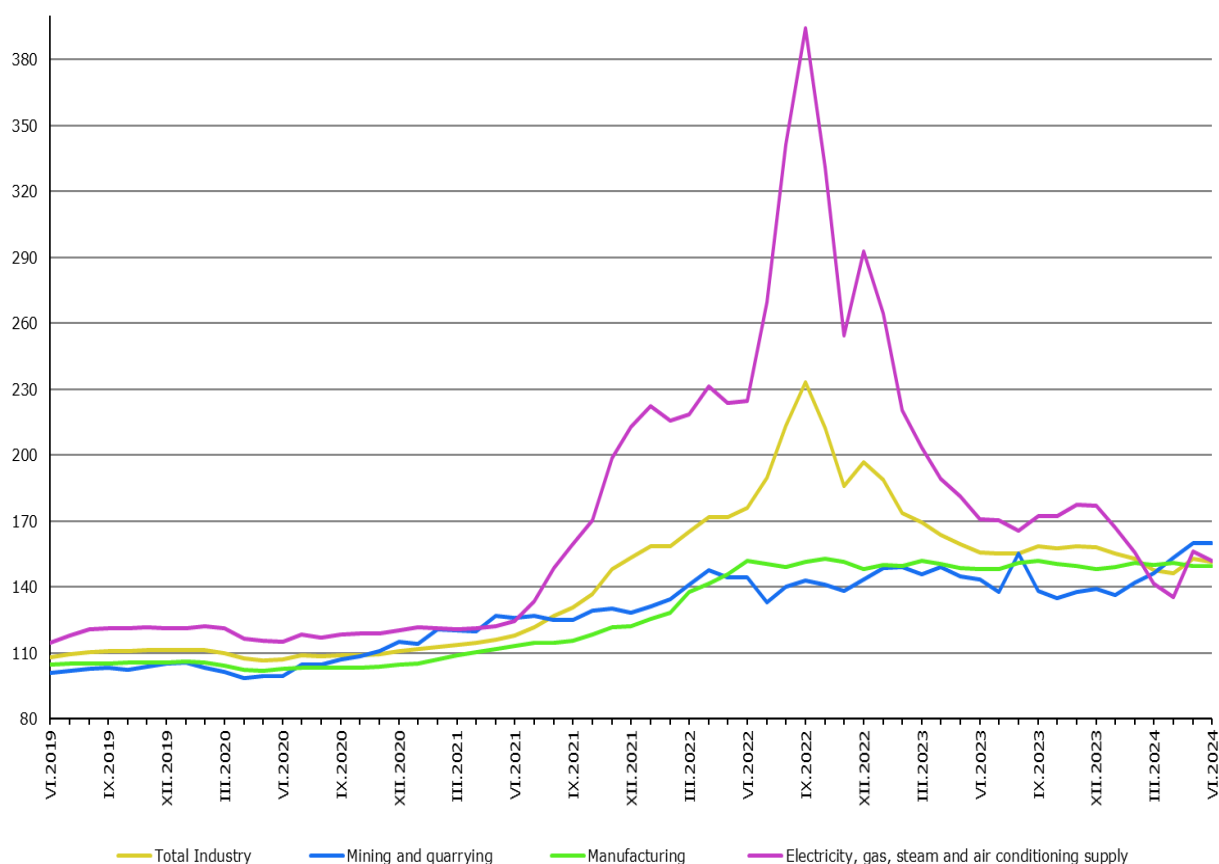
In the manufacturing, compared to the previous month, higher prices were reported in the manufacture of electrical equipment - by 1.2%, and in the manufacture of textiles - by 1.1%. Decrease was observed in the manufacture of leather and related products - by 2.6%, and in the manufacture of wood and of products of wood and cork, except furniture; manufacture of articles of straw and plaiting materials - by 1.1%.

The Producer Price Index on the Domestic Market fell by 2.8% compared to June 2023. A drop was reported in the electricity, gas, steam and air conditioning supply - by 11.1%. An increase was observed in the mining and quarrying industry - by 11.3%, and in the manufacturing industry - by 1.1%.

PRODUCER PRICE INDICES IN INDUSTRY, JUNE 2024

Compared to June 2023, in the manufacturing higher prices were seen in the manufacture of motor vehicles, trailers and semi-trailers - by 10.3%, in the manufacture of textiles - by 8.2%, and in the manufacture of wearing apparel - by 8.0%. A significant drop was registered in the manufacture of wood and products of wood and cork, except furniture; manufacture of articles of straw and plaiting materials - by 9.4%, in the manufacture of basic pharmaceutical products and pharmaceutical preparations - by 8.7%, and in the other manufacturing - by 4.1%.

3. Producer Price Indices on Non-domestic Market

The Producer Price Index on the Non-domestic Market increased by 0.6% in June 2024 compared to the previous month, and by 3.9% compared to the corresponding month of 2023.

Methodological notes

Producer Price Indices measure the average change in the prices of industrial products, which are produced and sold by Bulgarian enterprises. They can be considered an early measure of the current inflation process in the economy and they can be used for international comparisons. Information for the calculation of Producer Price Indices is received on the basis of monthly surveys on producer prices of industrial products sold on the domestic market and on industrial products sold on the non-domestic market. Producer price surveys are based on a constant sample of groups of products, and that sample is representative of the total industrial production.

Total Producer Price Indices are calculated from Producer Price Indices on the Domestic Market and Producer Price Indices on the Non-domestic Market weighted with the turnover structure on the domestic and the non-domestic market to the total value of turnover in the base year (2015).

Producer Price Indices on the Domestic Market are calculated at a constant base (2015), weighed with the turnover structure on the domestic market.

Producer Price Indices on the Non-domestic Market are calculated at a constant base (2015), weighed with the turnover structure on the non-domestic market.
