# TURNOVER INDICES IN 'RETAIL TRADE, EXCEPT OF MOTOR VEHICLES AND MOTORCYCLES' IN JULY 2019 ${ }^{1,2}$ 

According to the preliminary seasonally adjusted data ${ }^{3}$ in July 2019 the turnover in 'Retail trade, except of motor vehicles and motorcycles' at constant prices increased by $1.0 \%$ compared to the previous month.

In July 2019, the working day adjusted ${ }^{4}$ turnover in 'Retail trade, except of motor vehicles and motorcycles' marked an increase from $3.7 \%$ in comparison with the same month of the previous year.

## Monthly changes

In July 2019 compared to the previous month, increase of turnover was observed in the 'Retail sale of nonfood products except fuel' - by $1.5 \%$, in the 'Retail sale of automotive fuel' - by $1.0 \%$ and in the 'Retail sale of food, beverages and tobacco' - by $0.9 \%$.
In the 'Retail sale of non-food products except fuel' a more significant growth was reported in the 'Retail sale of computers, peripheral units and software; telecommunications equipment' and in the 'Retail sale via mail order houses or via Internet' - by $8.2 \%$ and by $7.0 \%$ respectively.

## Annual changes

In July 2019 compared to the same month of 2018, the turnover increased in the 'Retail sale of automotive fuel' (by $6.9 \%$ ), in the 'Retail sale of non-food products except fuel' (by $4.6 \%$ ) and in the 'Retail sale of food, beverages and tobacco' (by 1.3\%).
More significant growth in the 'Retail sale of non-food products except fuel' was observed in the 'Retail sale via mail order houses or via Internet' - by $27.8 \%$. A decline was reported in the 'Dispensing chemist; retail sale of medical and orthopaedic goods, cosmetic and toilet articles' - by $6.7 \%$.

    ${ }^{2}$ The monthly turnover indices reflect the short-term changes in the value of this indicator between two compared periods at constant prices. The information may be used to assess the current situation and the trends in the development of the trade sector as well as for short-term forecasts. In order to calculate the indices trade enterprises are observed by using a representative sample that forms about $70 \%$ of the annual receipts of the observed aggregate. The monthly turnover indices are calculated with 2015 as a base year.
    ${ }^{3}$ Seasonal adjustment is a statistical method, which eliminates the seasonal component of time series.
    ${ }^{44}$ Working day adjustment is an adjustment for variations caused by calendar effects, different number of calendar and working days in the months, national holydays and outliers (for example the presence of more non-working days in May could contribute to the decline in the retail trade).
