




TURNOVER INDICES IN 'RETAIL TRADE, EXCEPT OF MOTOR VEHICLES AND MOTORCYCLES' IN SEPTEMBER 2020^{1,2}

According to the preliminary seasonally adjusted data³ in September 2020 the turnover in 'Retail trade, except of motor vehicles and motorcycles' at constant prices increased by 2.8% compared to the previous month.

In September 2020, the working day adjusted⁴ turnover in 'Retail trade, except of motor vehicles and motorcycles' fell by 6.7% in comparison with the same month of the previous year.

¹Data for September 2020 are preliminary.

² The monthly turnover indices reflect the short-term changes in the value of this indicator between two compared periods at constant prices. The information may be used to assess the current situation and the trends in the development of the trade sector as well as for short-term forecasts. In order to calculate the indices trade enterprises are observed by using a representative sample that forms about 70% of the annual receipts of the observed aggregate. The monthly turnover indices are calculated with 2015 as a base year.

³ Seasonal adjustment is a statistical method, which eliminates the seasonal component of time series.

⁴ Working day adjustment is an adjustment for variations caused by calendar effects, different number of calendar and working days in the months, national holydays and outliers (for example the presence of more non-working days in May could contribute to the decline in the retail trade).






Monthly changes

In September 2020 compared to the previous month, increase of turnover was observed in the 'Retail sale of non-food products (including fuel) - by 4.0%, in the 'Retail sale of food, beverages and tobacco' and in the 'Retail sale of automotive fuel in specialised stores' - both by 2.9%.

In the 'Retail sale of non-food products except fuel' more significant increases of turnover were registered in the 'Other retail sale in non-specialised stores'- by 14.6%, in the 'Retail sale via mail order houses or via Internet' - by 6.7%, and in the 'Retail sale of textiles, clothing, footwear and leather goods in specialised stores' - by 6.6%.

Annual changes

In September 2020 compared to the same month of 2019, decline of turnover was observed in the 'Retail sale of automotive fuel in specialised stores' (15.2%), in the 'Retail sale of food, beverages and tobacco' (10.5%), and in the 'Retail sale of non-food products, except fuel' (0.3%).

Decrease of turnover in the 'Retail sale of non-food products, except fuel' was registered in the 'Retail sale of textiles, clothing, footwear and leather goods in specialised stores' - by 15.1%, in the 'Retail sale of information and communication equipment' - by 5.6%, and in the 'Dispensing chemist; retail sale of medical and orthopaedic goods, cosmetic and toilet articles in specialised stores'- by 1.2%. A rise was reported in the 'Retail sale via mail order houses or via Internet' - by 53.9%, in the 'Other retail sale in non-specialised stores' - by 6.3%, and in the 'Retail sale of audio and video equipment; hardware, paints and glass; electrical household appliances, etc. in specialised stores' - by 4.2%.

Figure 3. Change of turnover in 'Retail trade, except of motor vehicles and motorcycles' compared to the same month of the previous year (Working day adjusted)


