## TURNOVER INDICES IN 'RETAIL TRADE, EXCEPT OF MOTOR VEHICLES AND MOTORCYCLES' AUGUST 2021 ${ }^{1,2}$

According to the preliminary seasonally adjusted data ${ }^{3}$ in August 2021 the turnover in 'Retail trade, except of motor vehicles and motorcycles' at constant prices decreased by $1.1 \%$ compared to the previous month.
In August 2021, the calendar adjusted ${ }^{4}$ turnover in 'Retail trade, except of motor vehicles and motorcycles' grew by $12.0 \%$ in comparison with the same month of 2020 .

## Monthly changes

In August 2021, compared to the previous month, a decrease of turnover was observed in 'Retail sale of automotive fuel in specialized stores' - by $1.3 \%$ and in 'Retail sale of food, beverages and tobacco' - by $0.3 \%$, while in 'Retail sale of non-food products (except fuel)' was reported an increase - by $1.7 \%$.

In 'Retail sale of non-food products (except fuel)' an increase was noted in 'Retail sale via mail order houses or via Internet' - by $2.9 \%$ and in 'Dispensing chemist; retail sale of medical and orthopaedic goods, cosmetic and toilet articles in specialised stores' - by $2.0 \%$. A major decrease of turnover was seen in 'Retail sale of computers, peripheral units and software; telecommunications equipment' - by $2.6 \%$.

## Annual changes

In August 2021, compared to the same month of 2020, a growth of turnover was reported in 'Retail sale of non-food products, (except fuel)' ( $14.2 \%$ ), in 'Retail sale of food, beverages and tobacco' ( $10.5 \%$ ) and in 'Retail sale of automotive fuel in specialised stores' (8.5\%).

A greater rise of turnover in 'Retail sale of non-food products, (except fuel)' was registered in 'Dispensing chemist; retail sale of medical and orthopaedic goods, cosmetic and toilet articles in specialised stores' - by $37.7 \%$ and in the 'Other retail sale in non-specialised stores' - by $14.5 \%$. A decrease was observed only in 'Retail sale of textiles, clothing, footwear and leather goods in specialised stores' - by $6.2 \%$.

    ${ }^{2}$ The monthly turnover indices reflect the short-term changes in the value of this indicator between two compared periods at constant prices. The information may be used to assess the current situation and the trends in the development of the trade sector as well as for short-term forecasts. In order to calculate the indices trade enterprises are observed by using a representative sample that forms about $70 \%$ of the annual receipts of the observed aggregate. The monthly turnover indices are calculated with 2015 as a base year.
    ${ }^{3}$ Seasonal adjustment is a statistical method, which eliminates the seasonal component of time series.
    ${ }^{4}$ Calendar adjustment is an adjustment for variations caused by calendar effects, different number of calendar and working days in the months, national holidays and outliers (for example the presence of more non-working days in May could contribute to the decline in the retail trade).
