

# TRIPS OF BULGARIAN RESIDENTS ABROAD AND ARRIVALS OF VISITORS FROM ABROAD TO BULGARIA IN MARCH 2020

In March 2020, a decline in the trips of Bulgarian citizens abroad and the visits of foreigners to Bulgaria was registered due to the suspension of international flights and the closure of the land borders because of the worldwide spread of the COVID-19 coronavirus.


Figure 1. Trips of Bulgarian residents abroad by months

In March 2020, the number of the trips of Bulgarian residents abroad was 230.7 thousand (Annex, Table 1) or by 51.8% under the registered in March 2019 (Figure 1). In comparison with the same month of the previous year, a drop in the total number of the trips of Bulgarians to all observed countries was registered, as the most significant it was to: Italy - by 96.3%, Spain - by 79.9%, Serbia - by 55.9%, Germany - by 55.4%, the United Kingdom - by 53.1%, Greece - by 53.0%, Republic of North Macedonia - by 52.0%, and etc.




Figure 2. Structure of the trips of Bulgarian residents abroad by purpose of visit in March 2020

In comparison with March 2019, decreased the trips with all observed purposes was registered: 'holiday and recreation' - by 64.9%, 'professional' - by 52.1% and 'others' - by 44.0%. The trips with other purposes (as a guest, education and visit the cultural and sport events) in March 2020 composed the greatest share of the total number of trips of Bulgarian residents abroad - 51.4%, followed by those with professional purpose - 30.1%, and with holiday and recreation purposes - 18.5% (Figure 2).

In March 2020 most trips of Bulgarian citizens were made to: Turkey - 71.1 thousand, Greece - 34.0 thousand, Romania - 20.5 thousand, Serbia - 19.1 thousand, Republic of North Macedonia - 13.1 thousand, Germany - 10.9 thousand, Austria - 8.4 thousand, France - 8.3 thousand, the United Kingdom - 6.6 thousand, Belgium - 5.9 thousand (Figure 3).




Figure 4. Arrivals of visitors from abroad to Bulgaria by months

March 2020, the number of arrivals of visitors from abroad to Bulgaria was 312.8 thousand (Annex, Table 2) or by 43.7% less in comparison with March 2019 (Figure 4). A decrease in the trips with all observed purposes was registered: 'holiday and recreation' - by 60.7%, 'professional' - by 45.9% and 'others' (including as guest and passing transit) - by 26.6%. Transit passes through the country were 34.7% (108.5 thousand) of all visits of foreigners to Bulgaria.

The share of visits of EU citizens was 49.7% of the total number of foreigners' visits to Bulgaria in March 2020 or by 42.0% less in comparison with the same month of the previous year. A decline was registered in the visits of citizens from all observed countries, as the highest it was from: Germany - by 55.8%, France - by 54.6%, the United Kingdom - by 45.7%, Greece - by 36.2%, Romania - by 34.6%, and etc.

The visits of foreigners in the group 'Other European countries' decreased by 42.2%, as the highest decrease was observed in the visits of citizens of Republic of North Macedonia - by 55.8%.




Figure 5. Structure of visits of foreign citizens to Bulgaria by purpose in March 2020

In March 2020, the predominant share of the visits with other purposes - 53.6%, followed by trips with holiday and recreation purpose - 27.1%, and with professional purpose - 19.3% (Figure 5).



In March 2020 the most visits to Bulgaria were from: Turkey - 62.5 thousand, Romania - 54.5 thousand, Greece - 49.6 thousand, Serbia - 26.3 thousand, Republic of North Macedonia - 21.8 thousand, the United Kingdom - 15.2 thousand, Ukraine - 11.8 thousand, Poland - 7.6 thousand, Germany - 7.0 thousand, Russian federation - 5.1 thousand (Figure 6).

#### **Methodological notes**

The definitions recommended by the World Tourist Organization and the Methodological manual for tourism by Eurostat are applied by the National Statistical Institute.

In accordance with these definitions **an international tourist** is any person who travels to a country other than his/her permanent residence for less than a year and whose main purpose is not doing any activity for payment in place visited.

## The purposes of visiting a country are the following:

- Excursion, holiday or entertainment (visits to cultural or historical landmarks, sport events and other);
- Visiting friends and relatives;
- Professional purposes (business trips, participation in conferences, congresses, concluding deals, and etc.);
- Other (education, medical treatment, and etc.) purposes.

Statistical data on the trips of Bulgarian citizens travelling abroad and visits by foreigners to Bulgaria are obtained on the basis of monthly information received from the Ministry of Interior and sample survey of the National Statistical Institute among Bulgarian and foreign citizens passing through border check points.

Data on the number of the trips of the citizens of the European Union are estimated on the basis of the information obtained from the Ministry of Interior and the airport authorities. Data on the number of citizens from 'third countries' are obtained directly from the Ministry of Interior.

Data on the purposes of the trips are obtained on the basis of the NSI's regular monthly sample survey of passing Bulgarian and foreign citizens through the border check points.
